Rules for Busking at the Kelowna Farmers & Crafters Market

1 - All Buskers must report to the Info Tent before setting up to sign in

2 - Performances should always be appropriate for a family-based audience.

If you use an amp for your performance, it must be kept to no more than HALF of its capacity. Busking should never interfere with vendor/customer transactions

3 - Buskers are only permitted to perform in the designated areas as directed by Market Staff

4 - CD's may be sold but no other merchandise unless otherwise approved

5 - Performers under 18 must have the approval of their legal guardian.

6 - Performers under 16 should be accompanied by a responsible adult.

7 - Performers may put out a hat or case to collect donations but may not verbally ask the public for money. Signs must be appropriate, (no begging/soliciting signage)

8 - Please dress appropriately to face the public. A neat and clean appearance is most appealing.

9 - We are lucky to have many talented performers at our market. Buskers are not permitted to show up without being scheduled; Buskers must notify the Market Staff if they are not available to play their schedule timeslots. If you do not let us know you may lose your privilege playing at the market in the future.

10 - Always, performers must conduct themselves in a manner that is courteous to other entertainers, vendors, and public and be open to feedback from the market and its vendors. Remember that you are a welcomed guest and we do appreciate your contribution to the Kelowna Farmers & Crafters Market, but we must ensure the comfort of our customers and vendors alike.

In the case of any issues or conflicts involving the busker, the busker must abide by the decisions made and direction offered by Market Management.
